# **Title Page**

#### Introduction

Include the following elements in brief:

- **Purpose and Scope**: Note the overall purpose of the literature review and define what the review will and will not cover in relation to your research problem and questions.
- Organization of the Chapter: Indicate how the literature will be grouped (e.g., by themes, historical trends, theoretical approaches) and why this structure is appropriate for your study.
  - **Research Questions**: Include a brief restatement of your research questions to clarify how they shaped the inclusion and arrangement of sources.
- **Search Strategy**: Outline the databases you used (e.g., *ProQuest*, *JSTOR*), your key search terms, and your inclusion/exclusion criteria (e.g., publication date, peer-reviewed status, relevance to topic).
- **Source Requirements**: Confirm that your sources are primarily peer-reviewed journal articles. Non-scholarly sources such as dissertations, textbooks (e.g., Creswell), blogs, .com sites, and books are not permitted.
- Thematic Preview: List the main themes or categories you will cover and briefly note how they build toward your conceptual framework or study rationale.

### **Outline**

Present the major themes and subthemes you have identified in the existing literature that relate to your research problem and questions. Your outline should focus on synthesizing ideas, not summarizing studies. Each theme should reflect a pattern or conversation in the research and explain how this body of work connects to your study. Use bullet points or brief paragraphs for each subtheme. Under each subtheme, include at least two peer-reviewed sources and explain how they are connected, complementary, or contradictory, and how they will support your literature review.
